B. The Councilors are a key source of information on activities, programs, and policies of GAMA for NMMS and its leadership and members. In addition, the Councilors shall perform such other duties as determined by the Board. Councilors are expected to attend all NMMS Council meetings, all regular meetings of the GAMA Board, pertinent committee meetings and any other meetings as determined by the Association. Councilors serve for a term of three (3) years. Councilors representing the Greater Albuquerque Medical Association to the New Mexico Medical Society Council shall also serve as voting members of the Greater Albuquerque Medical Association Board of Trustees.

Helping Patients in Need

Access to same day care is a challenge for many patients. It can result in emergency room visits that are costly for the patient and, ultimately, unnecessary. Nationally, we've seen a variety of stories in the news highlighting these costly practices. The strain on patients can be exacerbated by the fact that some national freestanding emergency departments bill everything as emergency care, may not contract with payers, and balance bill patients. Last year Presbyterian set its sights on doing the exact opposite by opening an urgent care/emergency care facility where every patient receives emergency care but is billed at urgent care costs when emergent care is not actually necessary.

I am happy to announce we opened our first PresNow 24/7 Urgent and Emergency Care location in Albuquerque at Paseo del Norte and San Pedro earlier this month. These new facilities combine emergency care and urgent care in one location creating a venue of care where patients no longer must choose where to access the right care in their time of need. We never balance bill patients and work to contract with every payor to ensure all New

Mexicans have access.

We're proud that Presbyterian is the first health care provider to bring these innovative facilities to the Albuquerque metro area. When we talked to community residents, they told us they want to avoid the higher cost and longer wait times of an emergency room visit. They also want continued access to urgent care services beyond the early evening hours. So, we took action and are planning to open several of these facilities over the next year.

At the walk-in locations, each patient will be assessed by a clinician and then provided the care they need, whether it's urgent or emergent. This approach makes care more affordable for patients by avoiding the higher costs of emergency care if patients only require urgent care.

The locations will be staffed by experienced emergency physicians and advanced practice clinicians. They'll also have onsite laboratory and radiology services so patients can access care when they need it most. If a patient needs hospital care, such as a major operation or longer-term care, we will transfer them to the appropriate level of care.

Our clinical partnerships helped make our PresNow program possible and I'm grateful for their support and input as we continue to improve health care in our community. This is just the start. Look for more exciting news from Presbyterian soon.
